b. Political Research Quarterly - Harold Clarke/Ken Godwin

There were 221 submissions (highest ever) in 2005. We published 55 articles. 8 2 x 11 format has allowed for increase in articles, also presence in JSTOR has also increased exposure. They expressed thanks to Association, University of Utah, Editorial Board and assistants, authors, and reviewers.

c. Executive Director - Elizabeth Moulds

Betty reported that it has been a busy year. We are trying to do planning a little further out to take advantage of hotel deals. Albuquerque local arrangements took a great deal of time. A couple of policy areas addressed at the Executive Council meeting in September required followup.also were brought to our attention. In the area of child care, we have obtained resources and links for members with children. The second policy area was investment policy. There came a point where we wanted to be guided with a written policy. A committee was established and drafted policy which was adopted by the Executive Council yesterday. Finances are strong and have increased since last year. We seek contributions for receptions. Receptions provide great opportunities for networking. Membership report was distributed. Membership follows convention attendance. Thus, the year after next (after LasVegas) we will see an increase in membership. We worked hard on awards and made sure we had a full slate. Next year there are a number of things that will happen. Most notable is that the University of Utah will relinquish its publishing (but not its ownership) of the PRQ. Sage will take over publication. Thus a number of MOU□s will need to be drafted. Also the membership database collection will be updated. Most likely it will follow the APSA format. It has not been built so any suggestions would be helpful. We will be closing books on Albuquerque soon. March 8-10, 2006 Riviera Hotel, Las Vegas.
